Compatibility of Finish Floor Adhesives and Related Products with EXACOR® Panels

EXACOR[®] underlayment panels are fireresistant, high-density panels with acoustical performance and dimensional stability made from magnesium oxide (MgO) cement. When installing adhered finished floor coverings over the panels, we recommend using a compatible adhesive to achieve a proper bond between the panels and the finished flooring. For many finished flooring types, Huber Engineered Woods also recommends the use of a primer. This technical tip is only intended for use in selecting a compatible adhesive or related products when applying adhered finished flooring products directly over EXACOR panels.

Huber Engineered Woods has partnered



with various adhesive manufacturers to test and evaluate the compatibility between products from select adhesive brands and the EXACOR panel surface. Adhesives and other products identified as compatible are a result of satisfactory testing conducted by the applicable product manufacturer and do not reflect any internal testing performed by Huber Engineered Woods. Laboratory results should only be used as a guide, field conditions may vary. Always follow the installation guidelines provided by the product manufacturer.

Performance Evaluation

Various adhesives and other products were applied to the top surface (smooth side) of EXACOR panels, and those panels underwent applicable testing. Testing was completed in accordance with the testing protocol provided by the respective product manufacturer. Testing protocols may vary between manufacturers. Products that passed the manufacturers' required testing criteria for adhesion to the EXACOR panels were deemed compatible by the manufacturer for use over EXACOR panels.

Finished Floor Adhesive Manufacturers

All adhesives and other products recognized in this technical tip were evaluated by the manufacturers thereof. It is recommended to reach out to the manufacturer regarding compatibility of any products not listed.
